Looking Forward

We are all missing our worship services and are eagerly looking forward to the time we can gather together again. Your Executive Committee and your Session have been planning for that day by developing plans to stay safe while gathering.

We will adhere to strict social distancing guidelines including use of hand sanitizer, wearing of face coverings and maintaining 6 foot distance between people, except for those living in the same household. In order to maintain 6 foot spacing and accommodate all the people, you will be directed to specific seats within the Sanctuary. We are managing the seating to minimize the possibility of violating social distancing protocols.

There will also be several changes to the worship service itself:

- It is likely there will be a limit on the number of people that can attend any given service. If so, reservations will be required so we can manage the number of people in each service and also give everyone an opportunity to worship in the Sanctuary.
- The service will be streamlined and look very much like the services currently being livestreamed on Sunday. Both Sunday morning services will be livestreamed.
- Bulletins will not be available in the Sanctuary. We will continue to publish the bulletin via email and the church website.
- All articles which might be touched by multiple people including bibles, hymnals, attendance pads, etc. have been removed from the pews.

- There will not be a choir and congregational singing will be discouraged. Numerous studies have found that singing projects respiratory particles much further than normal speaking.
- Offering plates will not be passed. Baskets will be placed at the entrances and exits for your offerings.
- Communion will not be observed.
 A virtual communion that would be livestreamed separately from the worship service is a possibility.

We will continue to monitor the situation closely with a commitment to re-open for in-person worship as soon as our Executive Committee and Session concur that it is prudent to do so. Until then, please join us Sundays at 10:00 am via our livestream worship service on Facebook and the church website.

Session Highlights

On March 16, Session approved a motion to form an Executive Committee to respond to the quickly unfolding coronavirus issues. The Executive Committee has been meeting regularly and is monitoring the statistics and recommendations of the various authorities to determine when on-site services can resume. Listed below are actions of note:

WORSHIP:

Church services, Sunday School and Youth Group were suspended on March 16th.

Policies and protocols for re-opening the church for Worship Services have been drafted for use when it is safe to resume in person worship.

Jaromy Russo was hired to assist Vinnie Camuglia with the livestreaming of the Sunday morning worship service. It is not feasible for one person to operate all the equipment for livestreaming. Vinnie and Jaromy have done an outstanding job and we are deeply thankful for their crucial role in continuing our services. The purchase of a new computer for the AV system was approved (the current computer did not meet the technical requirements for livestreaming.)

The construction of a platform next to the sound booth for the two video cameras was approved and is under construction.

PROPERTY:

Various policies and expenditures have been approved regarding the cleaning of the premises.

Expenditures to repair leaks in the Sanctuary roof were approved and repairs completed.

Policies regarding small group meetings on property have been drafted for use when it is safe for our church groups to resume meeting.

A policy to suspend all outside group meetings (AA, NA, TOPS, etc.) until at least 2021 was approved.

MISSIONS:

Approval of a motion to conduct a backpack offering for local schools.

The Henderson Food Bank closed and asked us to re-direct our giving. Funds earmarked

for the Henderson Food Bank have been re-directed to the Salvation Army and the GVPC Secret Angel Fund.

Regular payments to our mission partners have continued.

PERSONNEL:

The Director of Music Ministries, the Director of Children's Ministries and the Nursery Attendant have unfortunately been laid off due to lack of work.

CHRISTIAN EDUCATION:

The production of a virtual Vacation Bible School was approved, which was a tremendous success! (see Christian Education on pg.3)

We appreciate the faith you have placed in us during this uncertain time. Your prayers for guidance and for protection of the church are appreciated.

Missions - Backpack Offering and Friends in the Desert

BACKPACK OFFERING - It is back to school time for the Clark Co. school district on August 24th, which means we are asking for your financial support to purchase backpacks and supplies for elementary and middle school students in need. Why are backpacks needed if the kids are home doing school online? The school district will be evaluating monthly whether to send the kids back to school, so, if they have backpacks, they will be ready to go. This also helps them keep their school

items organized and separate from the rest of the household. Finally, a backpack will give the students a sense of normalcy in an otherwise abnormal world and perhaps hope that they will be heading off to school soon. With all the layoffs taking place in our valley, your contributions will help the most vulnerable in our area schools. You may give online or mail in a check with "backpack" written in the memo. Our drive ends August 9th.

God has led us in some new directions that we may not have traveled except for the pandemic. He does work in mysterious and wonderful ways.


- We have quickly implemented and developed our livestreaming capability so we can continue worship services for our congregation and others who join us from around the world.
